No. 37-3/Leqsl/2004 dated 14th September 2005 and norms, standards, procedures and conditions prescribed by the Council from time to time and based on the recommendations of the Expert Committee and EC Sub-Committee, I am directed to convey the approval of the Council to Dasari Veer Raju & Gannan Ram Chandra Rao Memorial Trust, Vikash Enclave, Baraganiaguda Canal Chowk, P.O./P.S./Dist-Baragani-763010 Orissa-763010 for establishment of 'Vikash College of Engineering for Women (VCEW)' plot No. 2766, P.S. Dist-Baragani, Odisha for conduct of the following courses and intake.

The approval is valid for two years from the date of issue of this letter for getting affiliation with respective University and fulfilling State Govt requirements for admission.

The approval is valid for two years from the date of this letter. The Society/Trust/Institution shall obtain necessary affiliation/permission from the concerned affiliating University, as per the prescribed schedule for University Admission Authority or The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. In case the Institution could not commence the above mentioned courses for whatever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust shall have to make fresh application to AICTE for grant of fresh approval.

The approval is further subject to fulfilment of following conditions.

That the management shall provide adequate funds for development of land and building and for providing related infrastructure, institutional and other facilities as per Council's norms and standards laid down by the Council from time to time and for meeting recurring expenditure.

(b) That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.

(c) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.

(d) That the admission of the students shall be made only after the affiliating University / University under whose name the Institution is functioning / State Board has given permission to start the course.

(e) That the expenses incurred on development of the Institution or discontinuation of the course(s) or start and continuation of other intake capacity of seats without the prior approval of the Council.

(f) That the expenses incurred on development of the Institution or discontinuation of the course(s) or start and continuation of other intake capacity of seats without the prior approval of the Council.



- (f) That the institutions shall not have any collaborative arrangements with any Indian and/or Foreign Universities for conduct of technical education other than those approved by AICTE without obtaining prior approval from AICTE.
- (g) That the Institution shall not allow conduct of any unapproved course whether technical or non technical in the premises of AICTE approved institution/campus and /or in the name of the Institution without prior permission from AICTE.
- That the Institution shall operate only from the approved location and that the Institution shall not open any off campus study centers/ extension centers directly or in collaboration with any other Institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.
- That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/guardians of students in any form.
- That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or person authorized by it.
- That the Director/Principal and the teaching and other staff shall be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are paid as per the norms prescribed by the Council for time to time.
- (a) That the Institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
- (b) That the technical Institution shall publish an information booklet before commencement of the academic year giving details regarding the Institution and courses/programmes being conducted and details of infrastructure facilities including library etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be housed in the Institution Web-Site. The information shall be revised every year with updated information about all aspects of the Institution.
- (c) That it shall be mandatory for the technical Institutions to maintain a website providing the prescribed information. The website information must be continuously updated as and when changes take place.
- (d) That a compliance report in the prescribed format along with mandatory disclosure or fulfilment of the above conditions shall be submitted each year by the Institution within the time limit prescribed by the Council from time to time.
- (e) That if Technical Institution fails to disclose the information or suppress and/or misrepresent the information appropriate action could be initiated including withdrawal of AICTE approval.
- That all the laboratories, workshops etc. shall be equipped as per the syllabi of the concerned affliating University/University under whose ambit the Institution is functioning, and shall be in operational condition before seeking admissions.
- That a library shall be established with adequate number of titles, books, journals (both Indian & Foreign) etc. as per AICTE norms.
- That a computer center with adequate number of terminals, printers, legal software etc. shall be established as per AICTE norms.
- That a Joint FDR is required to be created for an amount and period prescribed by the Council from time to time.
- AICTE may carry out random inspections round the year any time for verifying the status of the Institutions to ensure maintenance of norms and standards.
- That the AICTE may also conduct inspections with or without notifying the dues to verify specific complaints of mis-representation, violation of norms and standards, mal-practices etc.
- That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grant/bond from the Central or State Government.

15. The Institute shall take appropriate measures for prevention of ragging in any form, in the light of directions of Supreme Court of India in Writ Petition No. 456/1998.  - a. Class rooms, labs and hostels to be made accessible to wheel chair users.
 - b. Resource room for visually impaired students.
 - c. Accessible library.
 - d. Coursering centre for disabled students.
 - e. Facility of sign language interpreter.
 - f. All students using assistive devices to be provided such devices.
17. That the Management shall strictly follow further conditions as may be specified by the council from time to time.
18. In the event of non-compliance by the Vikash College of Engineering for Women (VCEW) plot No. 2766, P.S. Dali-Baragarh, Odisha with regard to guidelines, norms and conditions prescribed from time to time the Council shall be free to take measures for withdrawal of its approval or recognition, without consideration of any related matter such that all liabilities arising out of such withdrawal would solely be that of the Vikash College of Engineering for Women (VCEW) plot No. 2766, P.S. Dali-Baragarh, Odisha.
